RENTAL TERMS AND CONDITIONS

1. The RENTER agrees to the cost of the rental at \$5/rental term (not to exceed 7 days). Expansions to the board game rented will be charged at 50% the rental term cost when rented alongside the base game. Rental Memberships shall be offered at \$15/mo. Memberships Rentals are subject to late fees and renewal terms as detailed below. The RENTER agrees to keep a credit card on file with The Guilded Grayland to be used in the event of the conditions listed below.
2. The RENTER shall keep and maintain the rented board game during the terms of the rental at their own cost and expense. The RENTER shall keep the board game in a good state of repair, normal wear and tear excepted.
3. The RENTER shall pay The Guilded Grayland full compensation for replacement and/or repair of any board game which is not returned because it is lost or stolen or any board game which is damaged and in need of repair to put it into the same condition it was in at the time of rental, normal wear and tear excepted. The Guilded Grayland will charge the RENTER'S credit card that is on file for the replacement cost and/or cost of repair.
4. The board game shall be returned to The Guilded Grayland. Rental charges are billed to the RENTER for the full term even if the board game is returned before the end of the term. If the board game is not returned during or at the end of the term, then the rental charges shall continue on a full-term basis (in addition to any late fees incurred, which shall not be less than 50% of the cost of a rental term) for any additional term or portion thereof until the board game is returned, the cost of renting exceeds the value of the board game, or two rental terms have elapsed, whichever occurs first.
5. If the board game has not been returned at the end of two rental terms, the full cost of the board game, less any rental fees paid, excluding late fees, will be charged to the RENTER via the card on file with The Guilded Grayland.
6. No allowance will be made for any rented board game which is claimed not to have been used. Acceptance of a returned board game to The Guilded Grayland does not constitute a waiver of any of the rights The Guilded Grayland has under the rental agreement. The Guilded Grayland agrees to verify the condition and completeness of the returned board game before re-stocking.
7. The Guilded Grayland makes no warranty of any kind regarding the rented board game, except that The Guilded Grayland shall replace the board game with identical or similar board game if the board game is incomplete to a degree that it is not reasonably playable. Such replacement shall be made as soon as practicable after RENTER returns the non-conforming board game.
8. The RENTER shall pay all reasonable attorney and other fees, the expenses and costs incurred by The Guilded Grayland in protection of its rights under this rental agreement and for any action taken by The Guilded Grayland to collect any amounts due The Guilded Grayland under this rental agreement.
9. These terms are accepted by the RENTER upon delivery of the terms to the RENTER.
